## General Information

- No equipment, canopies, tents, tables, chairs or signage will be provided. Vendors need to provide their own exhibit space materials.
- Exhibitors are responsible for furnishing and set-up of all tables, chairs, displays, etc. Vehicles will not be allowed to remain in the booth area. Parking will be provided nearby.
- All booth spaces are 10' by 10' and pre-assigned to vendors. Space location requests will be considered, but are not guaranteed. If your tent, canopy or exhibit space exceeds the 10' by 10' space, you must make note on the application and contact the Chamber. Multiple booth spaces may be purchased at a reduced cost for additional space.
- All exhibitors will be given a check in time between 7:00-8:20 am and must arrive at their allotted time. All booths must be completely set-up and open by 9:30 am. No exhibitors will be allowed to dismantle booths until 4:00 pm.
- Food Vendors must comply with Wake County Health Department regulations. Preparing food outside requires strict preparation and storage procedures. Health Dept. staff will inspect booths on Saturday morning. If you do not meet standards they will not allow you to serve to the public. Consult the Wake County Health Dept. for additional information or other questions, 919.856.7419.
- No electricity or water will be provided. Food vendors, please indicate on the application form if you are bringing a generator.
- Vendors will receive confirmation of their acceptance via mail. Vendors will also receive their booth number and vendor packet. Vendor packets will indicate an assigned time to set-up booths.
- All fees are non-refundable.
- Event Staff reserves the right to revoke or refuse to grant booth space at any time and shall not be liable to anyone for this action. Event Staff will determine acceptance and placement of booths.
- No booth will be allowed to set-up without the attached application and liability release form signed and dated.
- All applications are submitted pending approval of the Chamber of Commerce.
